## Why we are here today:

Every year on November 25th there is a day of remembrance and action to combat all forms of violence and discrimination against women, mothers, girls, daughters and queers. This day was officially introduced by the UN in 1999. This day can be traced back to the story of the Mirabal sisters. In 1960, they fought against the then dictator Rafael Trujillo in the Dominican Republic and were abducted, tortured and murdered by members of the military. The courage of the sisters in their fight against tyranny is now seen worldwide as a symbol of standing up against injustice of any kind. Gender-specific violence is still concealed, ignored, made invisible and presented as an individual case. This violence takes many forms, whether physical, psychological or caused by economic dependency. It is often difficult to grasp. But for so many it is part of everyday life, be it in relationships, in the family or at work. In Germany, a femicide - the murder of a woman because of her gender, for example by her (ex-)partner or family members - is committed every third day. In 2020, there were 139 women (BKA 2021). According to a Europe-wide study (FRA) in 2014, one in three women surveyed (33%) had experienced physical and/or sexual violence since the age of 15. In addition, violence against trans\* women is often not recorded as femicide because they are not recognized as women. These figures make it clear that the experiences of violence against women and queers are not isolated cases!

Only a small proportion of women and queers who experience violence make use of the existing advice and support facilities, such as women's shelters, women's centers or the help hotline (0800 116 016). Despite this, the Jena women's shelter did not have enough places for all those seeking protection last year and this year. The Istanbul-Convention is a binding instrument under international law preventing and combating violence against women and domestic violence. This includes the protection of those affected, prevention and prosecution as well as the legal equality of the sexes in constitutions and legal systems. In Germany have been identified serious shortcomings in the funding of violence protection in the implementation of the Istanbul Convention! Not even the required sum of 500 million euros is being invested in the expansion and promotion of violence protection facilities. Instead, there are even discussions about cutting further costs! This is a situation that is not acceptable to us! That is why we are here today!

## Our demands are as follows:

We demand the unrestricted and immediate implementation of the Istanbul Convention!

We call on the European Union, the Federal Republic of Germany, the state government and the city of Jena to do everything possible to combat violence against women and queers effectively and resolutely. We demand the provision of the necessary financial resources to do so!

We demand free accommodation and support for women in women's shelters and continuous public funding for them! We demand gender parity in all decision-making bodies!

We demand the financial support and protection of essential meeting and protection spaces for women and FLINTA\*s!

We demand: a stop to the perpetrator-victim reversal and the trivialization of reported violence in authorities and in court and, as a result, the improvement of quality and transparency in family court proceedings, through

- Including mandatory and regular further training of family court judges and professionals involved in proceedings (youth welfare offices, guardians ad litem, experts), in particular with regard to violence dynamics, perpetrator strategies and victim behavior! Monitoring bodies for the work of youth welfare offices, guardian's ad litem and experts.
- The obligation to investigate and prosecute every case of reported violence (domestic violence is not a private offence!)
- ♦ The expansion of the concept of violence in the justice system and the recognition and consideration of different forms of violence, including post-separation violence!
- ♦ The expansion of the concept of violence in the justice system and the recognition and consideration of different forms of violence, including post-separation violence!
- ♦ Child protection before access rights (no forced access in violent contexts)!

We demand greater consideration of the needs of particularly neglected groups, such as women with disabilities, migrant women, or queer people! We demand the lifting of the ban on the Kurdistan Workers' Party, which has enabled the structural criminalization of the Kurdish women's liberation movement and political femicides!

We demand a binding and long-term common struggle against patriarchy and fascism worldwide and for life - up the international solidarity!
